INDEPENDENT AUDITORS' REVIEW REPORT

To the Board of Directors of **NIIF Infrastructure Finance Limited**

- 1. We have reviewed the accompanying statement of unaudited financial results of NIIF Infrastructure Finance Limited ('the Company') for the quarter and nine months period ended December 31, 2024 ("the Statement") being submitted by the Company pursuant to the requirements of Regulations 52 read with Regulation 63(2) of the Securities Exchange Board of India (Listing, Obligations and Disclosure requirements) Regulations, 2015 ("the Listing Regulations").
- 2. The Statement, which is the responsibility of the Company's Management and approved by the Board of Directors of the Company, has been prepared in accordance with the recognition and measurement principles laid down in the Indian Accounting Standard 34 'Interim Financial Reporting' ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013 ("the Act") as amended read with relevant rules issued thereunder and the circulars, guidelines and directions issued by Reserve Bank of India ("RBI") from time to time, applicable to the Company ("RBI guidelines") and other accounting principles generally accepted in India and in compliance with the presentation and disclosure requirement under Regulation 33 and Regulation 52 of the Listing Regulations. Our responsibility is to express a conclusion on the Statement based on our review.
- 3. We conducted our review in accordance with the Standard on Review Engagement ("SRE") 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" issued by the Institute of Chartered Accountants of India. accordance with the relevant prudential norms issued by the Reserve Bank of India in respect of income recognition, asset classification, provisioning and other related matters.

- 5. Other Matters:

The report has been relied upon by G. M. Kapadia & Company, Joint auditors of the Company, for the purpose of their review of the Statement.
 - b. The audited financial results for year ended March 31, 2024 included in these financial results had been audited by Lodha & Company, Chartered Accountants and M.P Chitale & Company, Chartered Accountants who have expressed an unmodified opinion thereon vide their report dated May 3, 2024 which have been relied upon by G. M Kapadia & Company, Joint auditors of the Company, for the purpose of their review of the Statement.

Our conclusion on the financial results is not modified in respect of above matters.

Notes:

- 1 The aforesaid financial results of the Company were reviewed by the Audit Committee on February 05, 2025 and approved by the Board of Directors at their meeting held on February 06, 2025.
- 2 The above financial results of the Company have been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 ("Ind AS") prescribed under section 133 of the Companies Act, 2013 and in accordance with the requirement of Regulation 52 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended. The disclosures under Regulation 52(4) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for the period ended December 31, 2023 are enclosed as Annexure.
- 3 The Debentures issued by the Company have been assigned rating of "AAA" by ICRA Limited , CARE Ratings Limited & CRISIL Ratings Limited
- 4 There is no Debenture Redemption Reserve (DRR) created as the Non Banking Financial Companies registered with Reserve Bank of India are not required to create DRR for the privately placed debentures.
- 5 The Company is engaged in business of financing by way of loans (non banking financial services). All other activities of the Company revolve around the main business and accordingly, there are no separate reportable segments in terms of Ind AS 108 Operating Segments.
- 6 The Company is registered as Infrastructure Debt Fund (IDF-NBFC) with RBI. As per Section 10(47) of the Income Tax Act, any income of IDFs notified by Central Board of Direct Taxes (CBDT) for this purpose is exempt from income tax.
- 7 In terms of requirement as per RBI notification no RBI/2019-20/170 DOR (NBFC).CC.PD.No.109/22.10.106/2019-20 dated March 13, 2020 on implementation of Indian Accounting Standards, Non- Banking Financial Companies (NBFCs) are required to create an impairment reserve for any shortfall in impairment allowances under IND AS 109- Financial Instruments and Income Recognition, Asset Classification and Provisioning ('IRACP') norms (including provision on standard assets). The impairment allowance under IND AS 109 made by the Company exceeds the total provision required under IRACP (including standard asset provisioning), as at December 31, 2024 and accordingly, no amount is required to be transferred to impairment reserve.
- 8 The Company has neither transferred nor acquired any loans during quarter ended 31st December, 2024 without request at the instance of borrower as mentioned in per Chapter III of the 'Reserve Bank of India (Transfer of Loan Exposures) Directions, 2021' dated September 24, 2021. Accordingly, the disclosures as mentioned in aforsaid directions are not required to be made.
- 9 These results for the quarter and 9 months ended December 31, 2024 have been subjected to a "Limited Review" by the joint statutory auditors M.P. Chitale & Co, Chartered Accountants and G.M. Kapadia & Co, Chartered Accountants who have issued an unmodified review report thereon. The results for Q3 FY2024, 9 months ended FY2024 and FY2024 were reviewed/audited by erstwhile joint statutory auditors Lodha & Co. LLP, Chartered Accountants and M. P. Chitale & Co., Chartered Accountants on which they had issued an unmodified conclusion/opinion.
- 10 The Income of the company is exempt under section 10(47) of the Income Tax Act, 1961 wef 1st April 2019 vide Gazette notification. The Company has filed review of the said notification to get the exemption with retrospective effect since inception ie w.e.f. Financial year 2014-15 while recognizing the tax liability in financial statements in the interim. During the quarter, the Company has recognized balance tax liability (with interest) of Rs.10.01 crores pertaining to year 2019 combined with a few reconciliation adjustments. The total amount of Rs 10.31 crores is reflected in Income statement as "Tax adjustments for the earlier years".
- 11 The figures for previous periods have been regrouped wherever required to correspond with those of the current period.

Our responsibility is also to provide limited assurance that prima facie the Company has complied with the covenants mentioned in the Debenture Trust Deed including the Information Memorandum during the quarter ended December 31, 2024 in respect of listed debt securities.

For this purpose, we have:

- a. Obtained and read the Debenture Trust Deed and the Information Memorandum in respect of the secured Debentures and noted the asset cover percentage required to be maintained by the Company in respect of such Debentures and covenants applicable to the Company during the period; and
- b. Traced whether amounts mentioned in Annexure I have been correctly extracted from unaudited financial statements as at December 31, 2024 and other relevant records maintained by the Company.

We conducted our examination in accordance with the Guidance Note on Reports or Certificates for Special Purposes ("the Guidance Note") and Standards on Auditing issued by the Institute of Chartered Accountants of India ("ICAI").
